PROTECT YOURSELF & OTHERS



REPORT:

If you see materials on the roadway or that have fallen off a vehicle and pose a threat to public safety: Call 911 immediately from a safe spot.



PREVENT:

Keep all smaller waste items contained in the cab of the vehicle (Do not place loose trash or unsecured materials in truck bed).



AVOID A FINE.

Littering is a crime punishable with a fine up to \$300 in New Mexico.

PROTECT THE ENVIRONMENT:

Fully contain and properly dispose of all waste materials at an authorized and permitted landfill or disposal facility. Loose litter and debris pose potential threats to water sources, native soils & plants, air, livestock, and wildlife.

REPORT ILLEGAL DUMPING:

REPORT: If you witness illegal dumping in progress, find a safe place to call 911 as soon as possible. If you come across an illegal dump already on the landscape, report it ASAP.

Materials that are finer and smaller than the metal mesh holes need to be bagged or put into other secondary containment during transport in these types of trailers.
			Tight and secure cargo covers. Ensure tarps and nets are properly secured, extend all the way across the load, and installed tight enough so they don't lift off the cargo or rip apart at driving speed.

	5 5 5 5		Double-check. Always double-check your load. Ask yourself, "Would my loved ones be safe driving behind my vehicle?" If the answer is, "No," then take corrective action immediately.
	49		If you lose some, part, or all your load: According to New Mexico state law (NMS § 66-7- 364), loss of load materials on roadways is a criminal offense—which is why it is important to take measures to properly secure your load before transporting it. If bodily injury or property damage is caused by the material, fines and penalties increase. NMS § 66-7-364 also requires all released materials be immediately removed.
